About the position

Primary responsibilities

- Coordinate communication between patients, family members, care givers, medical and administrative staff, regulatory agencies, and/or other stakeholders.
- Schedule patient appointments following any MH protocols or guidelines to optimize patient flow.
- Check patients in to and out of appointments.
- Interview patients or their representatives to optimize provision of care.
- Provide accurate, timely, and complete documentation in patient records in accordance with MH policy.
- Sort and distribute mail, faxes, medical records and other correspondence to appropriate staff.
- Maintain an adequate supply of all patient forms and documents as needed.
- Assist all MH patients in accordance with all standards as established by MH, applicable professional communities, state and federal laws, and grant requirements for non-discrimination regardless of status, race, sex, religion, national origin, handicap, age, or ability to pay.

• Assist in the development, implementation, and performance of various patient and community outreach activities.
